- A child stops living with you
- A child leaves school
- You stop getting Income Support, Job Seekers Allowance (income based) or Employment & Support Allowance (income related)
- You stop getting Child Tax Credit
- You stop getting Pension Credit (guaranteed element)
- You or your partner jointly work 24 hours or more a week, with one of you working at least 16 hours or more
- You are a single parent and work 16 hours or more each week
- You start to receive Working Tax Credit
- Your annual gross income as assessed by HM Revenue & Customs, increases above £16,190
- If you start to receive Fostering Allowance
